## **Test/Track Day Declaration and Indemnity**

**All participants must sign the following indemnity before being permitted on the track.**

I wish to drive a vehicle or ride a motorcycle and participate in a test/track event at Jurby Motordrome organised by Jurby Motorsport Management Limited.

I understand that motorsport is dangerous and I am voluntarily exposing myself to risk of damage or loss, or personal injury by participating in a test/track day. I understand that the purpose of the event is to allow the participants to improve their skills and learn the handling characteristics of the vehicle(s) / motorcycle(s) they are using. I am aware that other track users will have varying levels of competence and my own riding or driving should therefore take this into account.

I understand that any insurance held by Jurby Motorsport Management Limited in respect of any liability which might arise out of the track event is limited, and that my own vehicle(s) / motorcycle(s), third party and public liability insurance (if any) is unlikely to cover me for my losses, liabilities or personal injury.

**I also understand the following;**

1. I myself am responsible for the way in which I use the track, and for wearing appropriate protective leathers/helmet/clothing where applicable. Please note for the June MX-5 event, we will not be running full motorsport track day activities thus helmets are optional and not compulsory.
2. Marshals/Officials will observe me on track and if I, or my vehicle, infringe any relevant rules or regulations or appear dangerous I may be excluded and lose track time. I understand that the payment(s) I have made to JMML will not be refundable under these circumstances.
3. All track discipline is under the auspices of the Clerk of the Course whose judgement is final.
4. I am aware I will be on the track at my own risk and that I will be liable for any damage caused to myself whilst onsite at Jurby Motordrome.
5. I confirm I have got personal travel insurance for my holiday to the Isle of Man including repatriation to a mainland UK hospital if required.

**I declare;**

1. That I am fit and healthy and that my eyesight (with lenses if to be worn) is adequate for track use and that I am physically capable of controlling my vehicle/motorcycle on the track whilst testing its performance on the track.
2. I will observe all instructions given by officials/marshals
3. That any vehicle/motorcycle for which I am responsible and that I will use on the track is in good and suitable mechanical condition.
4. That I will not participate in a track event whilst under the influence of alcohol or intoxicating drugs.
5. That I shall only be allowed access to the track after attending a briefing session.
6. That I have read and shall at all times comply with the Rules and Regulations as detailed overleaf.
7. I have read and understood the JMML GDPR Policy.
